What a year 2025 was!

After a long wait, Bakersfield and Kern County saw the opening of the Thomas M. Hardt Tower at Mercy Hospital Southwest on December 8, 2025.

The community was able to help celebrate this event with the Mercy Gala on October 24th and the Ribbon Cutting on December 4th. And what great celebrations they were.

Our generous community donors contributed almost \$22 million to the Friends of Mercy Foundation, including the Mercy employee giving groups of almost \$600 thousand. Adding the proceeds from our sale of the Karpe Ranch, the Foundation has made almost \$50 million available for the Tower project.

All of this occurred due to the tremendous partnership between our generous Community and the significant financial commitment by Dignity and CommonSpirit Health. This partnership resulted in an initial project commitment of over \$350 million to bring this state of the art and transformational healthcare facility to our Community. This facility

will enable Mercy Hospital to provide the best possible health care to our Community for years to come.

And just think, this is only the start. We now move on to adding more of the latest and greatest medical technology along with the needed doctors, nurses and staff to continue providing the best available health care to our Community.

Legacy of Sisters of Mercy



In 1778, a young girl named Catherine McAuley was born into a comfortable family. However, tragedy struck early, leaving Catherine and her siblings to face poverty and hardship. These experiences, coupled with a deep and unwavering faith, shaped her life's path. She witnessed firsthand the suffering of women and children, lacking basic necessities like food, shelter, and education.

After inheriting a sizeable sum of money, Catherine didn't indulge in luxury. Instead, she channeled her resources into a bold vision: the House of Mercy. Opened in 1827, this wasn't just a shelter; it was a beacon of hope, offering education and support to women and children. Catherine's tireless work attracted other women who shared her passion.

These women became known as "the walking sisters," a stark contrast to the cloistered nuns of the time. In 1831, at the urging of the Archbishop of Dublin, they formally established themselves as the Sisters of Mercy. Their influence spread throughout Ireland and beyond. Their commitment to education, healthcare, and social justice transformed communities by establishing schools, hospitals, and orphanages.

In 1910, at the request of the Archbishop of Los Angeles, and with the urging of parishioners from St. Francis church, 4 young Sisters of Mercy arrived at the train station in Bakersfield to establish a Catholic hospital to meet the needs of the growing community. Now, more than a century later, Mercy Hospital's legacy, built on the foundation laid by Catherine McAuley and all of the Sisters of Mercy who have graced our halls, continues to be interwoven in the lives of countless individuals in our community who have been touched by the Sister's healing ministry.



legacy of Adelaide Karpe

Housed in the Friends of Mercy Foundation are the annals of the Sisters of Mercy. In one of the volumes, a typewritten entry dated Oct. 1, 1971, states, "The sisters visited with Adelaide Karpe and her husband, Arthur. The latter is 86 years old and sick. Even with the services of the nurses around the clock, he looks poorly. Mrs. Karpe was most gracious and seemed exhausted from being up at night, off and on for a week."

Adelaide noticed Sister Marian Joseph Kelly, the ICU manager by day, also working tirelessly as a bedside nurse at night. Faced with nursing shortage, Sister Marian Joseph explained her dedication arose from a sense of duty. Arthur passed away shortly after, but the compassion of Sister Marian Joseph made a profound impression on his wife. Adelaide and Sister Marian Joseph became close friends and trusted confidantes. Having a philanthropic spirit, as did Arthur, Adelaide asked if she could gift a piece of land to Sister Marian Joseph to be sold to build a new hospital in the growing Bakersfield community.

As one who had taken a vow of poverty, Sister Marian Joseph requested that it be left to Mercy Hospital.

In 1944, the Karpe Family purchased a 1,167 acres plot near Arvin for \$10. When Adelaide passed away in 1979, the land was worth \$1 million. The same piece of land was sold in January 2021 for \$26 million. Those dollars are the first recognized gift to the expansion of Mercy Hospital Southwest and construction of the Thomas M. Hardt Tower.

This gift was a result of the connection of a Sister of Mercy and a grateful patient who was a visionary. Due to Adelaide's generosity, we are able to transform the health care landscape in Bakersfield with the building of the Thomas M. Hardt Tower. Adelaide and Sister Marian Joseph, and their acts of connection and compassion, remind us of the enduring and boundless power of Humankindness.



Legacy of Friend Raising

The Friends of Mercy Foundation, a non-profit organization in Bakersfield, California, boasts a rich history deeply intertwined with the city's healthcare landscape. Its origins trace back to 1910 with the donation of the St. Clair House, which became the first Mercy Hospital. This initial hospital was built and sustained through the generosity of the community, reflecting a long-standing philanthropic spirit.

Formally established in 1988 by Jim Burke and other community leaders, the Friends of Mercy Foundation emerged as a formalization of this long-standing community support. **Mr. Burke envisioned an organization focused on “friend raising” rather than fundraising.** Since then, the Foundation has raised over \$100 million to address the evolving healthcare needs of the community. This includes providing funding for equipment, technology, and various outreach programs.

Legacy of The Hardt Family



Tom Hardt, a Bakersfield native who spent decades developing and building the city's landscape, made a transformative gift to reshape Bakersfield's future. His unprecedented multi-million dollar contribution to the Friends of Mercy Foundation, allowed for the construction of the Thomas M. Hardt Tower. In addition to 106 private patient rooms, the Tower adds state-of-the-art operating rooms, adult and neonatal intensive care units, and expanded cardiac care. Tom and his wife Barbara's generosity isn't just about bricks and

mortar; it's about building a healthier community. Having witnessed firsthand the exceptional care provided by Mercy Hospital, and driven by a strong commitment to Bakersfield, they are ensuring residents receive advanced medical treatment close to home. Hardt Tower stands as a testament to his vision and a beacon of hope for the community's future health.


They have dedicated their resources to addressing homelessness, promoting better education, caring for the environment, providing nourishment, and fostering a sense of spirituality.

The Thomas M. Hardt Tower, a new four-story, 106-bed patient tower at Mercy Hospital Southwest, has officially opened, bringing cutting-edge healthcare services to the region.

Blessed by Rev. Father Hector Lopez of St. Philips, this 142,000 square foot expansion significantly enhances Mercy's operational capabilities, integrating advanced technology and a strong focus on patient comfort. Key additions include an expanded 24-room Intensive Care Unit, 18 private Neonatal Intensive Care Unit rooms, six new operating rooms, and new cardiology and neurosurgery services, previously unavailable in west Bakersfield. Enhanced food, sterilization, and pharmacy services complete the modernized facility, ensuring advanced, compassionate care for the community.




